and other administrators to improve their ability to provide strong instructional leadership and guide teaching and learning at school sites. The principals, in turn, provide support to teachers through staff conferences, opportunities for collaborative study and planning, and individual coaching based on ongoing classroom observations. Teachers and other staff are provided with both on and off-site professional development in all standards based curriculum content areas.

Beyond the content areas, professional development is provided in English Language Development, Gifted and Talented Education (GATE), differentiated instruction and educational technology. In addition, training is made available in classroom management and the effective use of assessment data and teacher data teams in meeting the needs of all students. A primary goal of the professional development program is ensuring that all students are served by skilled, highly qualified teachers

and that teachers are supported by strong, knowledgeable instructional leaders. Teachers are informed of the various opportunities for professional development and encouraged to attend.

Many at Sheldon have taken additional classes. Some of the topics have been: Math with Phil and Drew, Differentiation with Ed Services. Whole Brain Teaching strategies in addition to district provided professional development, Sheldon teachers take the lead in providing staff development in areas that support our CCSS focus and from disaggregated student data. Teachers collaborate on a regular basis and discuss teaching techniques. A major focus is on Language Arts and coordinating ELD strategies into the curriculum. They also meet to review testing and develop pacing in both ELA and Math.
