On November 6, 2012, the registered voters within the West Contra Costa Unified School boundaries approved Measure G. Measure G is a continuation of the previous parcel tax, Measure D. It will run for five years beginning July 1, 2014. The funds collected from Measure G is used to protect small class sizes, protecting core academic classes, retain excellent teachers, prepare students for post-secondary education paths, and school campus safety. Measure G allows a "Senior Citizen Exemption" for any parcel of taxable real property owned and occupied by at least one person 65 years of older.

To qualify for the senior citizen exemption, you must: 1) turn 65 years old before July 1, 2016; and, 2) own and occupy your property as your primary residence;

To qualify for exemption from the parcel tax during any tax year (July 1 – June 30), you must be age 65 years old by July 1 of any applicable year, be the owner of the parcel, and use the parcel as your principal place of residence.
